

## **FALSE ACCUSATIONS OF RAPE**

In England in 1998, there were 300 false accusations of rape against male school teachers by school girls. We do not know how many false accusations school girls made against other men but it is believed that another extensive area of such false accusations are made by girls whose fathers have left the matrimonial home and their mothers have a new boy friend. Many of these girls complain that their mother's new partner is not their father and react in a hostile way. To add to this many girls are enduring hormonal changes in their body which can affect their reason and cause them to be untruthful. A further consideration is that some are on cannabis and other drugs which can also affect their judgement and ability to be honest. Once they have made a false accusation it is very difficult and, indeed, shameful to admit it was a lie.

Mike Acton was accused of raping his daughter and went to prison. After nine years in prison, the girl admitted it was a lie. But his life was ruined.

In 1999, forty cases were heard in the High Court in England in which girls were found guilty of false accusations of rape but could only be charged with wasting police time. The victims of their dishonesty have suffered arrest, incarceration, disgrace, the gossiping tongues, having to employ solicitors and barristers and to appear in the Courts. They have had to find funds to defend the accusation and remortgaged the house or had to sell it and all because of some nasty school girl.

It must be made clear that if a man is guilty of rape he must be punished and, in my view, have the maximum sentence the Law provides.

A group of foul-mouthed women on a council estate in Portsmouth saw in the News of the World pictures of paedophiles one of which they took to be a man on their estate. They began a campaign against this man with verbal abuse and punching him in the street so that he was confined to his house. His windows were smashed and petrol bombs thrown in.

Eventually, the Police intervened and supplied evidence that this man was not the man in the News of the World and was not a paedophile. The women never offered any apology but said that what they did was right and that they would do it again. The leader of these women was a large woman usually with a cigarette hanging out of her mouth who swore and shouted in the most uncouth way.

A much respected headmaster from Shanklin on the Isle of Wight was falsely accused of inappropriately touching a boy. He was suspended and arrested. The boy insisted with his story. There was gossip and the usual foul-mouthed women. His life was made a misery and one day he went on to the Downs and hanged himself.

It was then proved that the boy had lied. And we can vouch for this head teacher. He was lovely, honest and a decent man.

It is often asserted that only men are paedophiles. This is not true. There have been innumerable cases of women who have found girls as young as eight to have sex with men and the girls are paid. In many cases the parents support this sex trade since it brings in income for the parents to buy drugs and alcohol and sit all day in front of the television, smoking.

These girls become withdrawn and develop social problems. Many also acquire health problems both physical and mental. A few years on, they cannot have a sexual relationship with a man and they may not be able to tell an interested suitor what they have been through. The girls may genuinely fall in love but, because of the abuse they have suffered, cannot have a relationship let alone a marriage.

Boys are also subject to sexual abuse often by homosexual men who engage in pederasty such as the composer Benjamin Britten and C W Leadbeater of the Theosophy Society.

Tony Blair was an awful Prime Minister. He received much money for the Labour Party from a pornography baron. While underage sex is illegal, he approved the Government advertisement aimed at young people to always carry a condom. He also advocated sex education for children as young as six years old.

This has two effects causing some children to fear and little girls to be terrified as to what will happen to them in a few years time, and others to investigate and experiment with sex.

There is another matter by which girls put themselves at risk and that is how they dress. The argument is made that girls should be able to wear whatever they like without being subject to lewd viewing or a sexual attack. It is a fact that young girls, schoolgirls and women wear sexy clothes to deliberately attract boys and men. They tease and tempt them in what has been called fashion flirting. In Christian culture and the culture of some religions, to tempt a man to sin is a sin in itself.

Normal red-blooded men respond to attractiveness in a female. It is natural. And if a schoolgirl constantly flashes herself to a male teacher it is sending out a persistent message. If he responds and behaves inappropriately he will be in trouble; if he does not, the girl may be offended and turn on him and falsely accuse him.

Many male school teachers have spoke of the girls who deliberately sit opposite with very short skirts and their legs open. They know what they are doing and why.

The Police have to investigate every accusation of a sexual nature and they can arrest a man on suspicion of rape or sexual assault and take him to the police station for a recorded interview. They can bail him or arrest him or take him before a magistrate who may be in an adjacent office. What an ordeal for an innocent man. It is also unfair if the alleged offence was a while ago and the man is expected to know where he was and who he was with some time ago.

Because real victims of rape suffer trauma they cannot report it quickly. But if all assaults were reported within 24 hours the Police could obtain definite evidence and this could lead to successful prosecutions and be a worthwhile deterrent.

Let us tell you about David. His wife was very unkind to him and never loved him. David eventually sued for divorce. He met an Irish girl who was also obtaining a divorce. They fell in love and while they did not live together they were man and wife. No one who have guessed that David would enter into such an affair but for the first time in his life he had the love of a woman. Then this Irish woman changed after five years and became a problem. She offered her 15 year old daughter to him as the girl wanted him sexually. He refused and the Irish girl dumped him although it was not for that reason but because she was furtively seeing her ex-husband behind his back.

David found out about her treachery and the Irish girl, knowing this, was feeling guilty, because she was. To eliminate her guilt she influenced her daughter to go to the Police accusing David of raping the teenage girl. The girl was carefully trained by her mother with details of what to say since she knew these details because of her intimacy with David over five years. The girl was also happy to do this because he had ignored all her overt sexual advances towards him.

He was arrested and investigated. The stress caused him to have heart trouble and other health and social problems all because of two spiteful women. The Police discovered that the girl was lying and that was that. But mother and daughter got away Scott free.

An example such as this, can justify the use of the word bitch which not only refers to a female dog but a spiteful woman.

There is a lot of nonsense expressed about human relationships. Robert Winston is a medical doctor and scientist and a Labour politician who sits in the House of Lords. He was once an adviser to the World Health Authority about human reproduction and has been involved in fertility research. I have him on video tape saying this:

“Whenever a girl or woman of any age, 8 to 38, considers a date with a boy or a man, she looks at him with only one thought in her mind, Will he make good babies with me?”

That is rubbish!

Should the law have a time limit as to when rape or sexual assault be reported?

Should all men keep a diary of where they are and with whom and what times?

Is hormonal problems an legitimate defence for a false accusation?

Is it right for the Police to arrest a man on the allegation of rape?

Should girls and women who falsely accuse men of sexual assault go on to a sex offenders register?

What action should, or could, if any, be taken against the Irish woman and her teenage daughter?

What justice should David seek?

What help and support should be given to men falsely accused while an investigation is impending?

How far is it true that if girls and women did not dress provocatively, assaults against them or against other women may lessen as shown in some statistics?

Is the increase of pornography and it being more readily available an incentive for men to commit sexual offences? If pornography did not exist would women be safer as is the case in some countries?
